Part I: Membership Categories

Membership is open to all persons who are interested in using the Linux Operating System and open source software in general. The membership of the **Society** shall consist of Ordinary members, and Student members of the **Society**. Persons who are pursuing full-time courses at any institution in Singapore shall be eligible for Student membership.

Part II: Entrance Fee and Annual Subscription Fee

Entrance fee is payable immediately and annual subscriptions are payable in advance on the first day of January. The entrance and annual subscription fees by class of membership is as follows:

Part III: Submission of Documents

1. Documents
 - (a) The application form must be filled completely.
 - (b) For Student membership, the completed application form must be returned together with certified true copies or proof of enrollment of full-time courses at any institution in Singapore. For renewal of annual subscription, a proof of enrollment must be submitted.
 - (c) All membership applications must be accompanied by a photocopy of the NRIC/Passport for verification.
 - (d) Members under the age of 21 must have the form signed by their legal guardian.
2. Return your application form, together with your cheque(s) or cash for the entrance/subscription fee. Cheque(s) should be crossed and made payable to "**The Linux Users Group (Singapore)**".
3. A copy of the constitution and a membership number will be issued when your application has been approved and after the necessary payment has been made.
